Pretoria – The Professional Board for Dietetics and Nutrition, under the auspices of the Health Professions Council of South Africa (HPCSA), will be hosting a roadshow for dietitians and nutritionists in Limpopo, Polokwane at the Bolivia Lodge on Friday, 28 July 2023.

This is the second stakeholder engagement to be conducted by the Board this year. The first roadshow took place in March, and it was held in Bloemfontein. The roadshow was attended by practitioners and students based in the Free State and Northern Cape provinces.

The purpose of these roadshows is to have direct consultation with practitioners regarding various developments regarding the professions.
