HPCSA PRACTITIONER ERASED FROM THE REGISTER

21 July 2020 For immediate release

Pretoria - The Health Professions Council of South Africa (HPCSA) continues to uphold its mandate of protecting the public and guiding the professions. On Saturday, 18 July 2020, the HPCSA Professional Conduct Committee erased Dr Luke Gordon off the register of practitioners in terms of Section 42 (1) (c) of the Act. Dr Gordon is a registered plastic and reconstruction surgeon who was charged before the Professional Conduct Committee on several charges relating to negligent performance of cosmetic procedures in respect of fourteen (14) patients.

The hearing involved fourteen (14) factual witnesses and six (6) expert witnesses who testified against Dr Gordon. The HPCSA filed fifty (50) pages of the heads of argument in respect of its principal submissions, excluding several heads of arguments that were filed for various interlocutory applications in casu.

The Committee found Dr Gordon (respondent) guilty of unprofessional conduct on nine (9) counts and not guilty in respect of five (5) counts. The Committee delivered the penalty against the respondent and found that aggravating circumstances far outweigh the mitigating factors.

Healthcare practitioners who are regulated by Council are guided by the ethical guidelines that indicate how practitioners should conduct themselves when handling patients. The HPCSA's fundamental objective is to always maintain the standard of the profession. The public must be assured that those who treat them are not only knowledgeable and skilled professionals, they also understand and adhere to the standards of conduct expected of them.
