# **RULES FOR THE REGISTRATION OF DIETITIANS**

The South African Medical and dental Council hereby makes the following rules in terms of <u>section 32</u> (1) of the Medical, Dental and Supplementary Health Service Professions Act, 1974 (Act 56 of 1974), in substitution of the rules published under Government Notice R. 2343 dated 3 December 1976:

- **1.** The council may register as a dietitian any person who satisfies the council that he has complied with the requirements set out in (1) and (2) hereof.

\*Provided that persons in possession of such qualification also be in possession of a certificate to prove that they have completed a period of six months practical training under the supervision of a registered dietitian at an institution in the Republic of South Africa approved by the council and of the professional board for this purpose. (2) Obtained practical training in dietetics by following a recognised postgraduate diploma in hospital dietetics extending over a period of one year or, in the case of recognised four year integrated courses, obtained 48 weeks practical training which

must have included an internship in a recognised teaching hospital for a continuous period of 26 weeks.

- 2. The council may register as a dietitian any person who passed an examination in dietetics conducted by the council in terms of section 32 of the Act.
- **3.** Where, in the case of an application for registration, the qualification on which the application is based has not already been approved by the Council, the applicant shall be required to cause the Professional Board for Dietetics and the council to be furnished with authoritative information as to the training required for such qualification, whereupon, if such standard of training is considered satisfactory by the council, such qualification may be recognised.
- 4. Notwithstanding anything to the contrary in these rules contained, it shall be lawful for the council to register as a dietitian any person who has not fully complied with these rules, it the council, after due inquiry, is satisfied that such person is competent to practise as a dietitian.
