# **HEALTH PROFESSIONS ACT 56 OF 1974**

# RULES RELATING TO THE REGISTRATION OF STUDENT SUPPLEMENTARY DIAGNOSTIC RADIOGRAPHERS

Published under Board Notice 23 in Government Gazette 10738 of 15 May 1987.

The South African Medical and Dental Council has in terms of <u>section 32</u> (1) (a) of the Medical, Dental and Supplementary Health Service Professions Act. 1974 (Act 56 of 1974), made the rules set out in the Schedule hereto.

## SCHEDULE

### DEFINITIONS

1. In these rules "the Act", means the Medical, Dental and Supplementary Health Service Professions Act, 1974 (Act 56 of 1974), and any expression to which a meaning has been assigned in the Act shall bear such meaning, and, unless the context otherwise indicates-

"Council" shall mean the South African Medical and Dental Council;

**"professional board"** shall mean the Professional Board for Radiography established in terms of <u>section 15</u> (1) of the Act,

"section" shall mean a section of the Act;

"student" shall mean a student in supplementary diagnostic radiography; and

"Registrar" the Registrar, South African Medical and Dental Council.

### **REGISTRATION OF STUDENTS IN SUPPLEMENTARY DIAGNOSTIC RADIOGRAPHY**

- 2. A student at a training institution in the Republic approved by the Council shall apply to the Registrar, for registration as a student-
  - (a) in the case of a student enrolled at such training institution as a student, within two months following such enrollment; or
  - (b) in the case of a student who on the date of publication of these rules has already enrolled at such training institution within two months after the date of publication of these rules.
- **3.** An application for registration as a student shall be made on a form obtainable from the Registrar for this purpose and shall be accompanied by-

- (a) a birth certificate or, if a birth certificate cannot be furnished, by a baptismal certificate or such other proof of his age and correct names as may be to the satisfaction of the Registrar;
- (b) senior certificate unless exemption from this requirement has been granted by the Professional board;
- (c) a certificate indicating that such student has enrolled for a qualification in supplementary diagnostic radiography, which certificate shall state the date on which he was so enrolled; and
- (d) a registration fee of R10.

**4.** (1) Where a student's name has been removed from the register and he resumes study for a

qualification in supplementary diagnostic radiography after having interrupted such study for a period of one year or longer, and application for his name to be restored to the register shall be made within two months of re-enrollment for such study and such application shall be accompanied by-

- (a) a certificate to the effect that such student has thus re-enrolled;
- (b) his original certificate of registration or a certified copy thereof issued by the Council for which a fee of 50c shall be payable; and
- (c) an amount of R1
- (2) Subject to the provisions of <u>section 19</u>, the name of a registered student who interrupts his studies for a period of more than one year but annually states in writing his intention of continuing his studies for a qualification in supplementary diagnostic radiography shall not be removed from the register of students in supplementary diagnostic radiograph.
- 5. Where an application for the registration of a name on the register of students or for its restoration thereto together with the documents and fees referred to in regulation 3 of 4, as the case may be is submitted after the date specified in regulation 2 or 4, as the case may be, such application shall be subject to an additional registration fee of 50c in respect of each month by which the application is submitted later than the date so specified.
- 6. The Registrar shall issue a registration certificate to a student who has been registered in terms of these regulations or whose name has been restored to the register of students.
- 7. The name of a student shall be removed from the register as soon as proof is furnished to the satisfaction of the Registrar that such student has discontinued his studies for a qualification in supplementary diagnostic radiography within the Republic.
